✧ PILGRIMAGE ITINERARY ✧

✧ Day 1 – May 11: Depart U.S.A.

Our pilgrimage begins today as we depart on our flight to Israel. Meals and drinks served aloft.

✧ Day 2 – May 12: Arrive Tel Aviv / Netanya

After arrival at Ben Gurion Airport in Tel Aviv, we will be met at the airport and then transfer to our hotel located on the shores of the Mediterranean in Netanya.



✧ Day 3 – May 13: Netanya / Tiberias

This morning, leave Netanya for Tiberias. Drive along the Mediterranean coast to Caesarea, capital of the ancient Roman Procurators of Judea. Here, St. Peter preached and St. Paul was imprisoned for two years. Visit the Roman Theater, Crusader's Moat, and the Byzantine Churches. Continue to the sparkling port city of Haifa. Ascend Mt. Carmel, home of the prophets Elijah and Elisha, to visit Stella Maris. Continue to Tiberias, our home for the next three nights.

✧ Day 4 – May 14: Tiberias

Following breakfast, drive to Cana of Galilee, where Our Lord performed the first miracle - changing water into wine at the wedding feast. Here, we'll invite couples to renew their

- marriage vows. Proceed to Nazareth to visit the
- Basilica of the Annunciation. In the afternoon
- take an excursion to the summit of Mt. Tabor to
- visit the site of the Transfiguration of Jesus.

✧ Day 5 – May 15: Tiberias

- This morning, enjoy a scenic boat ride across
- the Sea of Galilee to Capernaum, home of Jesus
- during His ministry. After visiting the synagogue
- where he taught, drive to Tabgha - site of the
- multiplication of loaves and fishes. Next, drive



- to the Mount of Beatitudes to visit the site of the
- Sermon on the Mount. The remainder of the day
- is free.

✧ Day 6 – May 16: Tiberias / Jerusalem

- We will depart Galilee late this morning for
- Jerusalem. Drive along the shores of the Sea
- of Galilee to the Baptismal Site on the Jordan
- River where we will renew our baptismal vows.
- Continue via the Jordan Valley to Bet Shean,
- where we'll view from our coach an ancient
- Roman amphitheater. From here, drive through
- the Judean wilderness to Jerusalem.

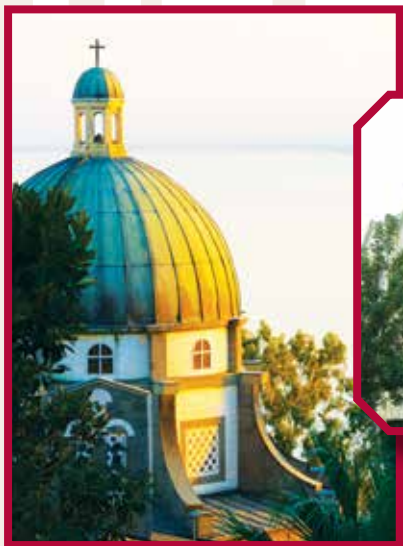
✧ Day 7 – May 17: Jerusalem

- This morning, drive to the top of the Mt. of
- Olives for a spectacular view of Jerusalem. Visit
- the Church of Pater Noster, Ascension, and

then walk the "Palm Sunday Road" to Dominus Flevit, where Our Lord wept over Jerusalem. Proceed to the Garden of Gethsemane to visit the Church of All Nations. In the afternoon, drive through the New City of Jerusalem to Ein Karem, birthplace of St. John the Baptist, to see the Visitation Church where Mary proclaimed her famous "Magnificat".

☞ **Day 8 – May 18: Jerusalem**

Drive to visit the Shepherd's Fields and then proceed to Bethlehem to visit the Nativity Church, built by the Emperor Constantine in the 4th century over the traditional grotto of Jesus' birth. Tour the Manger, the Grotto of St. Jerome, the Church of St. Catherine, and the Milk Grotto.



Then visit the Franciscan Family Center followed by some free time for shopping before returning to Jerusalem.

☞ **Day 9 – May 19: Jerusalem**

This morning, enter the Old City of Jerusalem. Visit the Church of St. Anne, the Pool of Bethesda and the Chapel of Flagellation. We will then walk along the Via Dolorosa to the Church of the Holy Sepulchre to visit Golgotha and the Tomb of Our Lord. In the afternoon proceed to Mt. Zion to visit the Upper Room, Dormition Abbey and St. Peter in Gallicantu where Peter denied Jesus three times.

☞ **Day 10 – May 20: Jerusalem / Tel Aviv**

Proceed to Bethany to visit the site of the House

of Mary, Martha & Lazarus and the Tomb of Lazarus. Continue through the Judean Wilderness and along the Dead Sea to Qumran to see the caves where the Dead Sea Scrolls were discovered. We will continue on to visit Jericho, the oldest known city in the Western world. From the top of the ancient "tel", we'll have an excellent view of Elisha's Fountain, the Qarantal and the Mount of Temptation. Return to Jerusalem and enjoy a farewell dinner this evening. After dinner we will transfer to Ben Gurion Airport in Tel Aviv to catch our late evening return flight home.

☞ **Day 11 – May 21: Tel Aviv / U.S.A.**

This morning we will arrive back in the United States following our overnight flight from Tel Aviv.

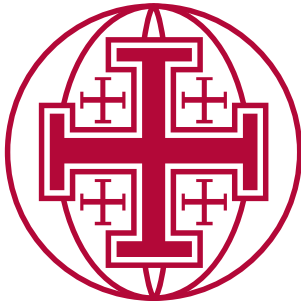

Reservations and Payment: Tekton Ministries requires a deposit of \$300.00 per person at the time of booking. This deposit forms a part of your final payment which is due 75 days prior to departure. Reservations made within 74 days of departure must be accompanied by payment in full. Payments made by credit card will incur a surcharge. Any reservations received within 45 days of departure will incur a late booking fee of \$100.00 per person. This pilgrimage is based upon a minimum of 21 total pilgrims. Surcharges may be assessed for a smaller group size.

Cancellations: All cancellations must be in writing. The following per person cancellation charges will apply in addition to any charges incurred by our suppliers: If canceled 91 days or more prior to departure, a \$50.00 administrative fee will be charged. If canceled 90 - 31 days prior to departure, \$150.00 will be charged. If canceled 30 - 15 days prior to departure, \$450.00 will be charged. If canceled 14 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking.

Travel Documents: A passport which is valid for 6 months past the date of your return flight home is required of all U. S. citizens. However, U.S. citizens do not require visas for Israel. If you are not a U.S. citizen, please call to find out if you need a visa. Tekton Ministries is not responsible for individual visas or passports.

Hotels: Accommodations are based on double occupancy rooms with private facilities. A limited number of single rooms are available at the supplement quoted and should be requested at the time of booking.

Air Transportation: Air travel is in economy class on Delta Airlines. Fares are based upon levels in effect at the time of printing and fares and flight schedules are subject to change without notice.

Baggage: Each passenger is allowed one checked bag and one carry-on. Tekton Ministries is not responsible for lost, damaged or stolen baggage.

Travel Insurance: We strongly recommend that you purchase comprehensive travel insurance for your trip. Registration information will be provided upon receipt of your deposit.

Not Included: Airline taxes/fuel surcharges (\$692.32 per person subject to change until the time of ticketing), passport/visa fees, personal travel insurance, laundry, beverages and items not on the regular menu of included meals, excess baggage charges, optional sightseeing and expenses of a personal nature.

Refunds: Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to Tekton Ministries/George's International Tours for such services will be promptly returned to the passenger, provided the passenger has not caused such cancellation and is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where Tekton Ministries/George's International Tours has remitted the payment to another registered seller of travel or a carrier and they default in providing the agreed-upon transportation or service

without providing a refund. In such a situation, Tekton Ministries/George's International Tours agrees to provide passenger with a written statement accompanied by a copy of the bank records establishing the disbursement of the payment, and if disbursed to a seller of travel, proof of their current registration.

Trust Account Disclosure: California law requires certain sellers of travel to have a trust account or bond. George's International Tours has such a trust account.

Travel Consumer Restitution Corporation ("TCRC"): George's International Tours is a participant in the Travel Consumer Restitution Corporation ("TCRC"). You, the passenger, may request reimbursement from TCRC if George's International Tours was registered and participating in the TCRC at the time of sale and the passenger is located in California at the time of payment. Please be advised that passengers purchasing from outside of California are not covered by the TCRC. Eligible passengers may file a claim with TCRC if the passenger is owed a refund of more than \$50 for transportation or travel services which George's International Tours failed to forward to a proper provider or if such money was not refunded to you when required. The maximum amount, which may be paid by the TCRC to any one passenger is the total amount paid on behalf of the passenger to George's International Tours, not to exceed \$15,000. A claim must be submitted to the TCRC within six months after the scheduled completion date of the travel. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to other civil remedies against a registered participating Seller of Travel for matters arising out of a sale for which you file a claim with the TCRC, if you were located in California at the time of the sale. You may request a claim form by writing to: Travel Consumer Restitution Corporation, P.O. Box 6001, Larkspur, CA 94977-6001; or by faxing a request to 415-927-7698.
