### ✧ Day 1: Thursday, July 21: Depart U.S.A.

Depart the United States on your overnight flight to Italy.

### ✧ Day 2: Friday, July 22: Arrive Rome

After arrival in the "Eternal City", we will be met by our local tour director and then embark on a tour of Rome with a visit to the Renaissance section of the city. See the Trevi Fountain where a coin thrown over your shoulder will guarantee you another visit to Rome; the Pantheon; Piazza Navona with Bernini's famous fountains; and



Campo de' Fiori which is one of the most colorful street markets in Rome. (D)

### ✧ Day 3: Saturday, July 23: Rome

A full day of exploring Rome begins with Mass at St. Peter's Basilica. Our guide then takes us through the Vatican Museum and the Sistine Chapel with its awesome frescoes painted by Michelangelo. In the afternoon our sightseeing includes visits to St. Mary Major Basilica, St. John Lateran, and the Holy Stairs. (B/D)

### ✧ Day 4: Sunday, July 24: Rome

- Today we will enjoy a full day sightseeing tour of Rome including visits to the Roman Forum, the Colosseum, St. Peter in Chains featuring Michelangelo's "Moses", and St. Paul Outside the Walls where Mass will be celebrated. Then
- proceed to the San Callisto Catacombs for a visit before returning to our hotel. (B/D)

### ✧ Day 5: Monday, July 25: Rome / Krakow

- Depart from Rome on your flight to Krakow. Upon arrival in Krakow check-in to our WYD



- accommodations. Dinner at the hotel. (B/D)

### ✧ Day 6: Tuesday, July 26: WYD Opening Mass

- Guided tour of Krakow, including entrance to Wawel Castle and visit the Basilica of Saint Mary (Mariacki) and remember St. Faustina's prayer for Divine Mercy. Evening participation in the opening of the World Youth Day in Krakow with the Cardinal Archbishop of Krakow. (B)

### ✧ Day 7: Wednesday, July 27: World Youth Day

- Morning Catechesis and World Youth Day



Activities. WYD participants, organized by language groups, will have catechesis session with bishops from all over the world. The sessions will take place in churches, schools, auditoriums and sports centers in Krakow. (B)

with bishops from all over the world. The sessions will take place in churches, schools, auditoriums and sports centers in Krakow. Arrival of Pope Francis and welcoming address. (B)

**Day 9: Friday, July 29: World Youth Day** Morning Catechesis and World Youth Day Activities. WYD participants, organized by language groups, will have catechesis session with bishops from all over the world. The sessions will take place in churches, schools, auditoriums and sports centers in Krakow. Take part in the Stations of the Cross. (B)

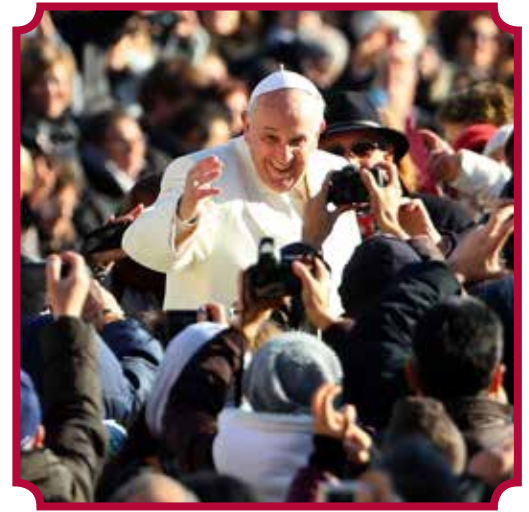
**Day 10: Saturday, July 30: World Youth Day** Young people will arrive at the site for the vigil. The pope will arrive and Eucharistic adoration will begin. An address is made by the Holy Father. Overnight vigil. (B)

**Day 11: Sunday, July 31: World Youth Day** The Pope will concelebrate Mass with thousands of bishops and priest. He will address the million plus young people, to send them out into the world to witness to their faith, as the Lord did with his Apostles. At the end of the Mass, the

Holy Father will announce the place where the next World Youth Day will be held. Culmination of World Youth Day 2016. (B)

**Day 12: Monday, August 1: Depart for Home** Following breakfast, transfer to the airport for return flight home. (B)

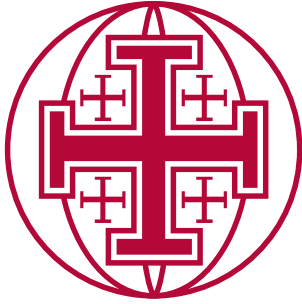

**Reservations and Payment:** For this pilgrimage, Tekton Ministries requires a deposit of \$300.00 per person by June 15th, 2015, and an additional deposit of \$1000 by October 15th, 2015. These deposits form a part of your final payment, the balance of which is due by March 15th, 2016. Reservations made after this deadline must be accompanied by payment in full. Payments made by credit card will incur a convenience fee of 4%. Any reservations received within 120 days of departure will incur a late booking fee of \$100.00 per person. This pilgrimage is based upon a minimum of 43 total pilgrims. Surcharges may be assessed for a smaller group size.

**Cancellations:** All cancellations must be in writing. The following per person cancellation charges will apply in addition to any charges incurred by our suppliers: If canceled 91 days or more prior to departure, a \$50.00 administrative fee will be charged. If canceled 90 - 31 days prior to departure, \$150.00 will be charged. If canceled 30 - 15 days prior to departure, \$450.00 will be charged. If canceled 14 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking.

**Travel Documents:** A passport which is valid for 6 months past the date of your return flight home is required of all U. S. citizens. However, U.S. citizens do not require visas for Poland or Italy. If you are not a U.S. citizen, please call to find out if you need a visa. Tekton Ministries is not responsible for individual visas or passports.

**Accommodations:** In both Rome and Poland we will be staying in 3-star hotels.

**Air Transportation:** Air travel is in economy class, to be decided once the pilgrimage comes into ticketing range. Fares are based upon levels in effect at the time of printing and fares and flight schedules are subject to change without notice.

**Baggage:** Each passenger is allowed one checked bag and one carry-on. Tekton Ministries is not responsible for lost, damaged or stolen baggage.

**Travel Insurance:** It is recommended that you purchase comprehensive travel insurance for your trip via the Tekton Ministries website. Registration information will be provided upon receipt of your deposit.

**Not Included:** World Youth Day registration fees and meal package, passport/visa fees, personal travel insurance, laundry, gratuities (to tour manager, local guides, drivers and hotel/restaurant staff), beverages, and items not on the regular menu of included meals, excess baggage charges, optional sightseeing and expenses of a personal nature.

**Refunds:** Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to Tekton Ministries/George's International Tours for such services will be promptly returned to the passenger, provided the passenger has not caused such cancellation and is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where Tekton Ministries/George's International Tours has remitted the payment to another registered seller of travel or a carrier and they default in providing the agreed-upon transportation or service without providing a refund. In such a situation, Tekton Ministries/

George's International Tours agrees to provide passenger with a written statement accompanied by a copy of the bank records establishing the disbursement of the payment, and if disbursed to a seller of travel, proof of their current registration.

**Trust Account Disclosure:** California law requires certain sellers of travel to have a trust account or bond. George's International Tours has such a trust account.

**Travel Consumer Restitution Corporation ("TCRC"):** George's International Tours is a participant in the Travel Consumer Restitution Corporation ("TCRC"). You, the passenger, may request reimbursement from TCRC if George's International Tours was registered and participating in the TCRC at the time of sale and the passenger is located in California at the time of payment. Please be advised that passengers purchasing from outside of California are not covered by the TCRC. Eligible passengers may file a claim with TCRC if the passenger is owed a refund of more than \$50 for transportation or travel services which George's International Tours failed to forward to a proper provider or if such money was not refunded to you when required. The maximum amount, which may be paid by the TCRC to any one passenger is the total amount paid on behalf of the passenger to George's International Tours, not to exceed \$15,000. A claim must be submitted to the TCRC within six months after the scheduled completion date of the travel. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to other civil remedies against a registered participating Seller of Travel for matters arising out of a sale for which you file a claim with the TCRC, if you were located in California at the time of the sale. You may request a claim form by writing to: Travel Consumer Restitution Corporation, P.O. Box 6001, Larkspur, CA 94977-6001; or by faxing a request to 415-927-7698.

The transportation companies concerned take no responsibility for any act, omission, or event during the time the passengers are not aboard their conveyances. The passenger contract issued by the transportation company shall constitute the sole contract between the transportation company and the passenger. Additional expenses incurred as a result of delay, change of schedules, illness, weather, strikes, hostilities, quarantine, government requisition of hotel space or any other reasons beyond the control of the tour operator or travel agent shall be borne by the passenger. # World Youth Day 2016

## Release of Liability and Permission for Minors to Travel

The following agreement provides **The Archdiocese of Indianapolis (AI)** and **Tekton Ministries (TM)** with emergency contact information, permission for minors to travel overseas and an individual release of liability. This agreement is in effect primarily for attending the World Youth Day in Poland from July 21st, 2016 to August 1st, 2016, but also includes any travel to other countries prior to or after the World Youth Day. Effective dates: July 21st, 2016 through August 1st, 2016 or upon return from Poland if returning at a later date. The information must be completed in full by every person traveling.

1. I agree to observe and obey all laws, posted rules and warnings, and further agree to follow any oral instructions or directions given by AI & TM or any of its contracted agents.
2. I recognize that there are certain inherent risks associated with international travel and I assume full responsibility for personal injury to myself and, if applicable, any family members, and further release and discharge AI & TM for injury, loss or damage to myself and my family arising out of my or my family's use of or presence upon the facilities, public or private, whether caused by the fault of myself, my family, AI & TM or any third parties during the entire trip within the effective dates stated above.
3. I agree to pay for all damages to person or property utilized by AI & TM during the course of the trip caused by my or my family's negligent, reckless or willful actions.
4. I agree to indemnify and defend AI & TM against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon any facilities, public or private, used during the entire trip.
5. I take full responsibility for my ability to participate in the activities of the trip. I understand that Italy and Poland have limited amenities to meet the needs of the handicapped, and AI & TM cannot guarantee access to handicapped facilities.
6. I agree to release from liability and hold harmless AI & TM for personal injury, property damage, loss of property, health problems, delays, or any action or omission by the air carrier, accommodation operators, rail service, public transportation, or participants of the tours including the chaperones and group leaders. The suppliers providing transportation, sightseeing arrangements, sleeping accommodations and guided tours for the entire trip are independent contractors and are not agents or employees of AI & TM. All coupons, receipts, reservations, and tickets issued or made on behalf of a passenger are subject to the terms and conditions specified by each of AI & TM's individual suppliers. By utilizing the service of the suppliers, you agree that AI & TM will not be liable for any accident, loss, injury, or damage to you or to those traveling with you in connection with any accommodations, transportation or any other services resulting directly or indirectly from any occurrence or conditions beyond its control, including war, acts of God, defects in vehicles, acts of terrorism, breakdown in equipment, thefts, delay or cancellation of or changes in itinerary for any act, omission, or event during the time you are on board or off the aircraft.
7. If any violation of these rules or the rules established by my group leaders is deemed grave, I understand that I may be required to return early. I agree to pay any penalties, or have my parent or guardian pay any penalties associated with changing my return flight date and the return flight date of one chaperon. These airline penalties for an early return will be paid prior to boarding the flight.
