✤ Day 1, May 15: Depart U.S.A.

Our pilgrimage begins today as we depart on our flight to France.

✤ Day 2, May 16: Arrive Lourdes

Upon arrival in Lourdes we will be welcomed by our local pilgrimage manager and transfer to our hotel. In 1858 Our Lady appeared to St. Bernadette, proclaiming herself the "Immaculate Conception". This evening you can participate in the Blessed Sacrament Procession and the Candlelight Procession.



🕆 Day 3, May 17: Lourdes

You have all day to experience the special atmosphere of this beautiful town. Attend Mass at the Grotto of Massabielle, the site where the Virgin appeared. Also visit the Basilica of Pius X (the world's largest underground church), see the house where Bernadette lived during the Apparitions, and visit several of the sites where the miraculous cures have taken place.

🕆 Day 4, May 18: Lourdes

Today is a free day for prayer and personal activities. In the afternoon, you may want to visit the miraculous healing baths. After dinner, join the candlelight procession one final time for your last night in Lourdes.



✤ Day 5, May 19: Lourdes/Loyola/Burgos After breakfast, we depart Lourdes for Loyola, the birthplace of St. Ignatius of Loyola, founder of the Jesuits. Here, we will see the 17th-century Basilica dedicated to St. Ignatius and his family home behind the sanctuary. We will have time to pray at the most venerated room where Ignatius at age 30, was brought following his serious wounding at the Battle of Pamplona. In the afternoon complete our day's journey ending in Burgos where there is a magnificent limestone cathedral where we will have Mass.



Day 6, May 20: Burgos/Segovia/Avila

In the morning depart Burgos for Segovia where we will venerate the tomb shrine of St. John of the Cross and celebrate Mass. In the afternoon, we will arrive in Avila to visit the Convent of St. Teresa that was built over her childhood house after her canonization in 1515. Overnight in Avila.

Day 7, May 21: Avila / Salamanca / Fatima
This morning we will depart Avila for Alba
de Tormes to visit the Carmelite Convent
which contains St. Teresa's incorrupt arm
and heart before continuing to Salamanca

and the Cathedrals Vieja and Nueva for • Mass. The afternoon will be spent en route • to Fatima and the concluding destination of • our pilgrimage. •

🕆 Day 8, May 22: Fatima

As in most small villages in the early years of the century, the parish church was the center of life and faith in Fatima. It was here that the three children were baptized and Lucy made her first confession at six years of age.



The kindly priest who heard her confession told her to consecrate herself to the Blessed Virgin and she immediately did this in front of the statue of Our Lady of the Rosary. The following day she took Holy Communion for the first time. Jacinta also frequently came here to pray. Once on the feast of the Ascension, the Blessed Virgin appeared and asked them • to pray the rosary every day and ask for • world peace. After Mass at the Chapel of the • Apparitions, visit the Basilica to see the site of Francisco and Jacinta's graves and the village where the three children lived. Continue to Valinhos where Our Lady appeared to the children following their release. This evening participate in the Stations of the Cross along the Via Sacre, site of the first Apparition.

🕆 Day 9, May 23: Fatima

Today will be a free day in Fatima to spend • in prayer and exploration of this sacred site. • Mass will be celebrated as a group at the • Basilica. •

Day 10, May 24: Fatima/Lisbon/ U.S.A.

Our pilgrim journey concludes today as we transfer from Fatima to Lisbon to catch our return flight home.



Reservations and Payment: Tekton Ministries requires a deposit of \$300.00 per person at the time of booking. This deposit forms a part of your final payment which is due 75 days prior to departure. Reservations made within 74 days of departure must be accompanied by payment in full. Payments made by credit card will incur a convenience fee. Any reservations received within 45 days of departure will incur a late booking fee of \$100.00 per person. This pilgrimage is based upon a minimum of 40 total pilgrims. Surcharges may be assessed for a smaller group size.

Cancellations: All cancellations must be in writing. The following per person cancellation charges will apply in addition to any airline penalties and charges incurred by our suppliers: If canceled 91 days or more prior to departure, a \$75.00 administrative fee will be charged. If canceled 90 - 31 days prior to departure, \$150.00 will be charged. If canceled 30 - 15 days prior to departure, \$450.00 will be charged. If canceled 14 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking.

Travel Documents: A passport which is valid for 6 months past the date of your return flight home is required of all U. S. citizens. However, U.S. citizens do not require visas for France, Spain or Portugal. If you are not a U.S. citizen, please call to find out if you need a visa. Tekton Ministries is not responsible for individual visas or passports.

Hotels: Accommodations are based on double occupancy rooms with private facilities. A limited number of single rooms are available at the supplement quoted and should be requested at the time of booking.

Air Transportation: Air travel is in economy class on Air France Airlines. Fares are based upon levels in effect at the time of printing and fares and flight schedules are subject to change without notice.

Baggage: Each passenger is allowed one checked bag and one carryon. Tekton Ministries is not responsible for lost, damaged or stolen baggage.

Travel Insurance: We strongly recommend that you purchase comprehensive travel insurance for your trip. Registration information will be provided upon receipt of your deposit.

Not Included: Passport/visa fees, airline taxes/fuel surcharges (currently \$329.60 subject to change until the time of ticketing), gratuities to tour manager, local guides, drivers, and hotel/ restaurant staff, personal travel insurance, laundry, beverages and items not on the regular menu of included meals, excess baggage charges, optional sightseeing and expenses of a personal nature.

Refunds: Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to Tekton Ministries/George's International Tours for such services will be promptly returned to the passenger, <u>provided</u> the passenger has not caused such cancellation and is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where Tekton Ministries/George's International Tours has remitted the payment to another registered seller of travel or a carrier and

they default in providing the agreed-upon transportation or service without providing a refund. In such a situation, Tekton Ministries/ George's International Tours agrees to provide passenger with a written statement accompanied by a copy of the bank records establishing the disbursement of the payment, and if disbursed to a seller of travel, proof of their current registration.

Trust Account Disclosure: California law requires certain sellers of travel to have a trust account or bond. George's International Tours has such a trust account.

Travel Consumer Restitution Corporation ("TCRC"): George's International Tours is a participant in the Travel Consumer Restitution Corporation ("TCRC"). You, the passenger, may request reimbursement from TCRC if George's International Tours was registered and participating in the TCRC at the time of sale and the passenger is located in California at the time of payment. Please be advised that passengers purchasing from outside of California are not covered by the TCRC. Eligible passengers may file a claim with TCRC if the passenger is owed a refund of more than \$50 for transportation or travel services which George's International Tours failed to forward to a proper provider or if such money was not refunded to you when required. The maximum amount, which may be paid by the TCRC to any one passenger is the total amount paid on behalf of the passenger to George's International Tours, not to exceed \$15,000. A claim must be submitted to the TCRC within six months after the scheduled completion date of the travel. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to other civil remedies against a registered participating Seller of Travel for matters arising out of a sale for which you file a claim with the TCRC, if you were located in California at the time of the sale. You may request a claim form by writing to: Travel Consumer Restitution Corporation, P.O. Box 6001, Larkspur, CA 94977-6001; or by faxing a request to 415-927-7698.
