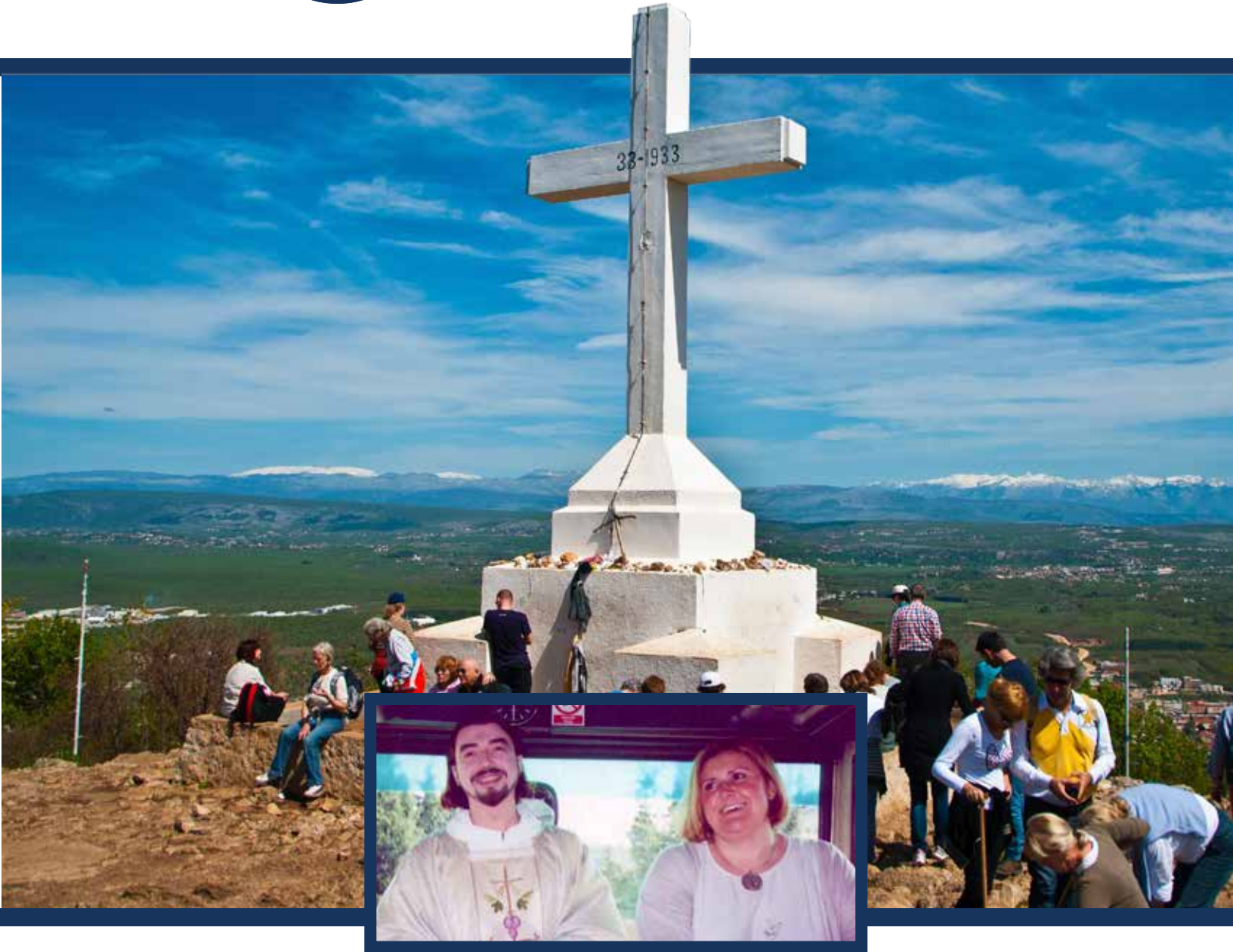

PILGRIMAGE ITINERARY

Pilgrims on this combined pilgrimage-retreat will enjoy the guidance and leadership of Ann Vucic, early witness to the Medjugorje apparitions. Born just two miles away from Medjugorje, Ann's family immigrated to the United States when she was two years old. They returned to their homeland to visit relatives in 1981, and were there when the Blessed Mother began appearing to six children in Medjugorje. Hearing of the apparitions, Ann and her family rushed to the site, where Ann became an early witness to the appearances. Her life forever changed, she is now dedicated to sharing the story of Medjugorje and encouraging others to grow in love for Our Lady and her Son.

Ann meet pilgrims upon arrival in Sarajevo, the group will travel to the small village of Medjugorje, in Bosnia-Herzegovina. Medjugorje is an experience of complete immersion into a rhythm of prayer, in a setting steeped in the Lord's peace. Many have said it is the closest to Heaven on earth they have experienced.

In June of 1991, six young people from this small village claimed that the Blessed Virgin Mary had appeared to them, bringing messages of peace and conversion for all people and stressing the need for each person to turn their hearts back to God. She continues to appear today, urging all people to place God first in their lives and families, and providing the means for doing this: daily conversion, prayer of the heart, fasting, penance, Mass, monthly confession, reading Scripture and living it.

After Medjugorje, you will drive to Krk and travel with your guide to the town of Malinska, on Krk Island, in the northern Adriatic Sea of Croatia, where you will partake of a 3-day retreat with Fr. Zlatko Sudac, a Croatian stigmatist priest. Fr. Sudac received the cross on his forehead in May 1999, 11



months after his ordination, and wounds on his wrists, feet, and side in October 2000. As you might imagine, an encounter with him is a powerful and life-changing experience. Though he has many gifts of the Holy Spirit, one of his greatest gifts is the gift of preaching, through which it is always his intention to lead souls deeper into the heart of Christ and the Church.

Following the retreat, you will drive to Zagreb and have the opportunity to explore the fascinating "Upper Town" area. Gain an appreciation of Croat culture as you stroll through the Dolac Market, soak in the beauty of St. Mark's Square, and enjoy the quiet hustle and bustle of this historic town.

● **Day 1 – November 9th: Depart New York (JFK)**
Flight from New York to Sarajevo. Meals served on flight.

● **Day 2 – November 10th: Sarajevo / Medjugorje**
Upon arrival in Sarajevo, we will drive to Medjugorje. Dinner will be waiting for us upon our arrival at our pansion.

● **Day 3-6 November 11th-14th: Medjugorje**
Our activities will include:

● On our first full day in Medjugorje, Ann will provide you with a comprehensive orientation about Medjugorje and the apparitions, and you will be given a brief tour of the area, so that you are familiar with everything.

● We will have two meals each day at our pansion (breakfast every morning, and either lunch or dinner, depending on the events scheduled that day). There are many restaurants in Medjugorje for people who may wish to have a third meal each day.

● We will be able to attend the Holy Mass in English every day at St. James church (usually at 10:00 am), with English speaking pilgrims from throughout the world.

● We will be able to participate in the international program of prayer each evening, which includes the rosary, the availability of the Sacrament of Reconciliation, the international Mass for all pilgrims, prayers for healing and Adoration of the Blessed Sacrament.

● We will climb Apparition Hill, site where Our Lady first appeared to the visionaries.

● You will have the option of climbing Cross Mountain, praying the Stations of the Cross as we ascend to the summit.



●We will visit the Cenacolo Community, where young people with various addictions will share their testimonies about how they found freedom and a new life through prayer, work, and the Sacraments.

●We will visit the Oasis of Peace community and hear their testimony. They are a religious community which was founded as a fruit of Medjugorje.

●We will hear talks by visionaries when possible.

●We will hear talks by Medjugorje priests and other locals, when possible.

●There will be plenty of time for shopping as well, so that you can bring back a piece of Medjugorje to your loved ones at home.

Many of these activities will be subject to availability and weather. You will always have the option of participating in group activities or spending time by yourself.

● **Day 7– November 15th: Medjugorje / Krk**

After Mass, depart from Medjugorje, for the 6-7 hour drive to Krk Island. We will stop for lunch somewhere on the drive, and then arrive at the hotel in the afternoon.

● **Day 8– November 16th: Retreat Day**

Morning and afternoon are free to explore the island on your own. Retreat with Fr. Sudac begins at 5:00 pm, with introductory talk and Holy Mass, followed by dinner.

● **Day 9– November 17th: Retreat Day**

Talks by Fr. Sudac, healing and deliverance prayers, Holy Mass. Breakfast, lunch and dinner included.

● **Day 10– November 18th: Retreat Day**

Morning session with Fr. Sudac, followed by Holy Mass. Retreat concludes with lunch. After lunch, drive 2-3 hours to Zagreb, check into hotel for overnight in Zagreb. Explore Zagreb's Upper Town. Dinner at hotel.

● **Day 11– November 19th: Zagreb**

Today will be free to explore the old town of Zagreb, the Dolac Market, and St. Mark's Square. Dinner will be at the hotel.

● **Day 12– November 20th: Zagreb / New York (JFK)**

Departure for home, taking home wonderful memories of your journey with Our Lady in Medjugorje and retreat Fr. Zlatko Sudac.

Reservations and Payment: Tekton Ministries requires a deposit of \$300.00 per person at the time of booking. This deposit forms a part of your final payment which is due 75 days prior to departure. Reservations made within 74 days of departure must be accompanied by payment in full. Payments made by credit card will incur a convenience fee. Any reservations received within 45 days of departure will incur a late booking fee of \$100.00 per person. This pilgrimage is based upon a minimum of 21 total pilgrims. Surcharges may be assessed for a smaller group size.

Cancellations: All cancellations must be in writing. The following per person cancellation charges will apply in addition to any airline penalties and charges incurred by our suppliers: If canceled 91 days or more prior to departure, a \$75.00 administrative fee will be charged. If canceled 90 - 31 days prior to departure, \$175.00 will be charged. If canceled 30 - 15 days prior to departure, \$450.00 will be charged. If canceled 14 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking.

Travel Documents: A passport which is valid for 6 months past the date of your return flight home is required of all U. S. citizens. However, U.S. citizens do not require visas for Croatia/Bosnia Herzegovina. If you are not a U.S. citizen, please call to find out if you need a visa. Tekton Ministries is not responsible for individual visas or passports.

Hotels: Accommodations are based on double occupancy rooms with private facilities. A limited number of single rooms are available at the supplement quoted and should be requested at the time of booking.

Air Transportation: Air travel is in economy class on Lufthansa. Fares are based upon levels in effect at the time of printing and fares and flight schedules are subject to change without notice. Note that any ticketing changes made within 90 days of your departure date will incur airline penalties.

Baggage: Each passenger is allowed one checked bag and one carry-on. Tekton Ministries is not responsible for lost, damaged or stolen baggage.

Travel Insurance: We strongly recommend that you purchase comprehensive travel insurance for your trip. Registration information will be provided upon receipt of your deposit.

Not Included: Airline taxes/fuel surcharges (currently \$476.38 per person, but subject to change until the time of ticketing), gratuities to guide, driver, and hotel staff, passport/visa fees, personal travel insurance, laundry, beverages and items not on the regular menu of included meals, excess baggage charges, optional sightseeing and expenses of a personal nature.

Refunds: Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to Tekton Ministries/George's International Tours for such services will be promptly returned to the passenger, provided the passenger has not caused such cancellation and is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where Tekton Ministries/George's International Tours has remitted the

payment to another registered seller of travel or a carrier and they default in providing the agreed-upon transportation or service without providing a refund. In such a situation, Tekton Ministries/George's International Tours agrees to provide passenger with a written statement accompanied by a copy of the bank records establishing the disbursement of the payment, and if disbursed to a seller of travel, proof of their current registration.

Trust Account Disclosure: California law requires certain sellers of travel to have a trust account or bond. George's International Tours has such a trust account.

Travel Consumer Restitution Corporation ("TCRC"): George's International Tours is a participant in the Travel Consumer Restitution Corporation ("TCRC"). You, the passenger, may request reimbursement from TCRC if George's International Tours was registered and participating in the TCRC at the time of sale and the passenger is located in California at the time of payment. Please be advised that passengers purchasing from outside of California are not covered by the TCRC. Eligible passengers may file a claim with TCRC if the passenger is owed a refund of more than \$50 for transportation or travel services which George's International Tours failed to forward to a proper provider or if such money was not refunded to you when required. The maximum amount, which may be paid by the TCRC to any one passenger is the total amount paid on behalf of the passenger to George's International Tours, not to exceed \$15,000. A claim must be submitted to the TCRC within six months after the scheduled completion date of the travel. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to other civil remedies against a registered participating Seller of Travel for matters arising out of a sale for which you file a claim with the TCRC, if you were located in California at the time of the sale. Responsibility Clause: Tekton Ministries, George's International Tours and/or their cooperating selling agents and/or their suppliers of services offer these tours for sale only on the express understanding that they themselves do not perform or in any way assume liability for the performance of the individual components, transfers, hotels, flights, car, motorcoaches, etc. of these tours and act only to combine these components into a single unit of sale for the convenience of the general public, and are not responsible therefore, either directly or indirectly, for any loss, accident, or injury which may result from any act, omission, negligence in or responsible for performing or providing these component services. The transportation companies concerned take no responsibility for any act, omission, or event during the time the passengers are not aboard their conveyances. The passenger contract issued by the transportation company shall constitute the sole contract between the transportation company and the passenger. Additional expenses incurred as a result of delay, change of schedules, illness, weather, strikes, hostilities, quarantine, government requisition of hotel space or any other reasons beyond the control of the tour operator or travel agent shall be borne by the passenger. Tour operator reserves the right to substitute hotels of similar category if necessary and to alter itineraries. Your deposit certifies that you agree with the above terms and conditions.
